Dr. Leo Nesmith, Task Assigned Chief Safety & Security Officer -Handheld Metal Detectors

New hire, Jamie Alberti will be assuming the role of Chief Safety & Security Officer in a week and a half. Dr. Nesmith will return to his previous role.

There has been an uptick in incidents lately, specifically fights and weapons on campus. This is not unique to our county or our state. Social media is an incentive for students to showcase the antics.

Procedural manuals are in place to ensure that students are not victims of profiling, particularly students of color or ESE students. This manual will be fluid as protocols are tested and adjusted in initial stages. This manual will not be public records due to safety protections. The board discussed and approved Policy 2010 Use of Handheld Metal Detectors on School Property. This policy includes ANY individual on a school campus. Athletic events are already implementing wanding, especially at football games.

The wands will be used for randomized screening and as needed for possible threats. Randomized approach ensures that rights are preserved. Randomizing eliminates issues with profiling and bias. The system will generate a school and three classrooms. Secondary schools are the focus, however, elementary is not excluded. Four principals volunteered to be part of the pilot of the initial wanding. There are scripts utilized to allay anxiety and maintain uniformity. There are male and female officers on hand for the screenings. Students are separated by gender.



Three Steps to Access Student Grades

Step 1: Go to single sign-on (SSO) page at sso.browardschools.com and click "Log in with Active Directory"



Step 2: Enter the Student ID and password to log in to the Clever Launchpad

- Enter Student ID number (example: 06#########)
- Enter password (if forgotten, please contact your school)
- Click Sign In button to access Clever

Step 3: Select Virtual Counselor for report cards OR Pinnacle for current courses

- To view report card and interim reports, click Virtual Counselor
- To view grades, test results and attendance for current courses, click Pinnacle
- Launch app and follow on-screen prompts for menu of options

Helpful Tips and Information

- Install the <u>Clever extension</u> in your browser so that SSO can take care of the logins for you
- Parents/Guardians please assist your student to select secure passwords that include letters, numbers and symbols and which does not use date of birth or other personal information
- New students are provided credentials by their school. Returning students can use their existing log in information; a new password is strongly recommended every three to six months.
- · Student records are maintained individually; therefore you must log in separately using each student's credentials to access grades.
- BCPS employees cannot access their students' grades from a District device or server. For access, open a new browser window (e.g., Incognito, InPrivate, Private Browsing, new private window terms vary by browser) to log in with your child's credentials.

Facilities Task Force- Dr. Nathalie Lynch-Walsh

The following were discussed at both the FTF Subcommittee and regular meeting:

- Citizens Concerned about our Children (CCC) Settlement Agreement
 - o Facilities-Related Conditions
 - Understanding Facilities-Related Indicators
- Definitions and Implementation
- Impact of the recession
- State Requirements for Educational Facilities (SREF)
 - o The Difference Between SREF Net and Gross Square Footage (see pgs 85-86)
 - o Min, Norm, and Max Net Square Footage Requirements
- The CCC, SREF, and Stranahan HS's Cafeteria

The Facilities-related CCC conditions and indicators can be found in the March FTF Report.

- 8.1 While the original five-year plan (2014-15 AADEFP) approved after the 2014 General Obligation Bond prioritized projects into years 1, 2, 3, 4, and 5, the method behind how projects were prioritized was not based on bringing facilities into parity with District standards.
- 8.2 Relates to athletic facilities (indicator 5.1). Tracks were resurfaced as part of the SMART bond, but 6-lane tracks were not converted to the 8-lane District standard.
- 8.3 Yes, the DEFP is available annually for public review.
- 8.4 Relates to whether a school meets the minimum standards as specified in SREF (Standard 1), District Ed Specs (Standard 2), and Florida Building Code (Standard 3). The December School Board resolution exempted Stranahan's cafeteria from one of the sets of standards the District agreed to comply with in the CCC settlement. As Ed Specs are related to SREF, and the Board did not exempt the cafeteria from the District's Education Specifications, there is now a conflict, as compliance with one necessitates compliance with the other.
- 8.5 Does the DEFP contain a list of ADA compliance projects, and do facilities meet ADA requirements? We recently spent a significant amount of time discussing elevator access, which is now being addressed. What other ADA compliance projects remain unaddressed?

May agenda topics: In addition to following up on previous agenda topics, we will be looking at research related to steering committees and the benefits of external stakeholder input, financial closeouts of pre-SMART projects, infusing sub-contractor performance into design and construction evaluations, understanding the Change Order process, and volunteer requirements under the Behavioral Threat Assessment Policy.
