**Dr. A. Hickman:** Chief Student Support Initiatives & Recovery

#### **Mindfulness**

Four guiding pillars: Social Emotional Learning, Mindfulness, Mental Health and Wellness, & Equity/Diversity. Students are struggling to reconnect in the new

school year. Dr. Hickman's department is supplying resources for staff/students and communities.

Go to link at Mental Health and Wellness page, Mindfulness Toolkits. These resources have been added to student and staff Canvas sites as well as Child Abuse Reporting links and a link to reach out to someone to talk. There are videos as well as resources in multiple languages and to meet diverse needs. There are ongoing staff and family workshops.

All schools have been required to implement 10 minutes of mindfulness each day with students. Live sessions help to support this implementation.

#### 5.5 E Student Attendance in eLearning

Staff and families are asked to be flexible. Teachers are asked to utilize any evidence of participation to indicate attendance as we work through technical concerns. This evidence could be a verbal interaction, turning on a camera. The evidence is to be "observable." Per Mr. Shaver, logging in also counts as a present for attendance. Enrollment was initially down by 7,000 but has since risen by 1,000. There is a marked increase in home school enrollment, however, many students are re-enrolling as time continues. Recording an excused absence is available on school websites under Contact, then report an absence.

# 2170 E Face Coverings

After consulting with health officials, all persons on campuses must wear a face covering over **both** the mouth and nose. Schools will provide face masks to students who arrive on campus without a mask. This will be an extensive cost for the District when students return to brick and mortar. Some funding is through federal sources. Current ordering includes 3-5 masks per person on campus. Face coverings must conform to the dress code. The fabrics may not contain images/slogans that disrupt the learning environment.

# 2020-2021 School Reopening Plans – Status of 2-week analysis and /or Phase 2 opening

According to the Superintendent, we are still under code red, however, the positivity rate is decreasing. Other concerns are the ability to provide PPE and hospitalization rates. The school board will be revisiting this every two weeks. It is recommended that we be below 5% positivity rate for 14 days or more. The CDC and Department of Health are providing the guiding recommendations.

#### Policy 6000.1 - SBW 8.25.2020

The policy lacked a consideration for make-up work over suspension periods. This language is recommended by DAC to be added to the make -up work policy. The committee also suggests that language for all three levels (elementary, middle, high school) be aligned within the policy. The committee also recommended that the language of "two days" be clarified to be "two school days." Quizzes/tests are recommended to be included in the language as well to read "all assignments including quizzes and tests."

#### SAT/ACT

# DAC Motion on dual enrollment (9.11.2019)

We move that the District form a committee to do an in-depth analysis of prior-year participation in the dual enrollment program for purposes of determining if the reduction or elimination of non-primary participation would make room in the budget for more primary participation and therefore eliminate or loosen the need for indiscriminate limits on the number of courses which students may take. "Non-primary" here means dual enrollment classes which are not meaningfully related to a student's field of study and/or dual enrollment classes for subjects which are offered as an A.P., AICE or IB class at the student's high school. The committee shall include a representative from the District Advisory Council and the Gifted Advisory Council.

A committee will be formed to continue to address this. The goal is to gain traction and reach out to Title I (Cathy Diaz), Equity and Diversity, Gifted Advisory (Veronica Newmeyer), ACCEL is state law.

Motion to take back to the School Board by Linda Ferrer and seconded by Veronica Newmeyer.
