#### **Future State School-Based Security Model**

#### Our NEW Security Approach:

- Focus on replicating and scaling existing best practices
- Develop procedures and training to clarify role expectations and performance management for security staff
- Budget for security staffing to move to District managed (food services model)
- Build a cohesive security team as part of a cohesive school team
- Allocate District resources to supplement school-based staff




## **School-based Security Model**

#### **NEW Additional Supports & Services:**

- District pre-screens and recruits for school-based security staff
- Administrators choose from qualified/screened pool of employees
- Training on standardized processes/procedures provided by the District to school-based personnel
- Expanded training department to scale train-the-trainer
- NEW Area Security Manager, Campus Security Manager and Director roles to ensure fidelity of implementation




## Safety, Security & Emergency Preparedness Org: Status





## Safety, Security & Emergency Preparedness Org Chart





## **Legislative Updates**

# Senate Bill (SB) 7030

#### Key To-Do's:

1. District school boards to promote the use of the mobile suspicious activity reporting tool (FortifyFL)



- 2. Requires drills for active shooter and hostage situations to be developmentally appropriate and age-appropriate.
- 3. Requires district school boards and charter school governing boards to adopt an active assailant response plan and provide procedures training. By October 1, 2019.



## **Legislative Updates**

# SB 7030 Continued:

- Requires school principals to notify all school personnel of their responsibilities to report any incident that poses a threat to school safety to the principal or to his or her designee, and that the disposition of each such incident is properly documented.
- Requires the School Safety Specialist (Chief Brian Katz) to collaborate with public safety agencies to conduct an annual school security risk assessment using FSSAT at each public school by October 1 and provide recommendations.

## School-Based Security - Our Next 60 Days....

- Tell Your Friends: Security team selection process & protocols:
  - 1) apply thru Applitrack,
  - 2) qualification/screening,
  - 3)pre-match requests,
  - 4) school matching
  - 5)training
- Hiring push continues additional 200+ Campus Monitors, Security Specialist assignments, filling Area Security Manager (ASM) roles
- Campus Security Manager role first reading 8/20
- New/Additional Radios (~500 for Security Staff) in progress
- FSSAT/School Risk Assessments & Active Assailant Plan in progress
